This Memorandum of Understanding (here in after called as the 'MoU') is entered into on this the 22<sup>nd</sup> day of September 2021 by and between.

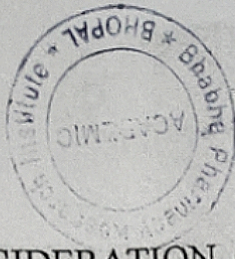

#### CLAUSE 1


#### CO-OPERATION

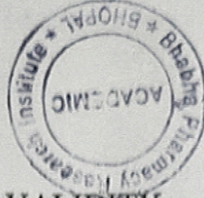
- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.

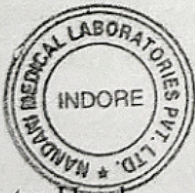
