WHEREAS:


- A) First Party is a Higher Educational Institution named: Bhabha Polytechnic Pharmacy, Bhabha University, Bhopal.

- D) **Vantage International (India) Inc.** - the Second Party is engaged in Manufacturing and Export of Pharma Product.

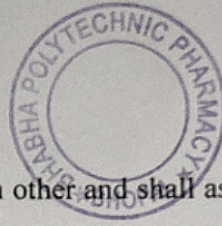

2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.


CLAUSE 3 VALIDITY
