- 6. The land is free from all encumbrances. The deponent also states that the land is exclusively designated for running the educational institution and that the necessary permission for change of land use has been obtained from the competent authority.

8 (6) "In case the contents of the affidavit are found to be incorrect or false, the society or trust or the institution concerned shall be liable for civil and criminal action under the relevant provisions of the Indian Penal Code and the relevant, and shall also be liable for withdrawal of recognition by the Regional Committee concerned".
